## Tournament Details:

- ◆ There are two tournaments, a boys and girls.
- ◆ The entry fee is \$175 per team. Payment is due by Friday, Jan. 14, 2011.
- ◆ Each team will play a guaranteed three games.
- ◆ Each game will have 25-minute halves with a 5-minute intermission.
- ◆ Team listed first will be the home team and wear light colored Jersey.
- ◆ There will be no overtime in pool play. In championship game, if the game ends in a tie, there will be two five-minute periods. If the game is still tied, a shootout will be used until a winner is crowned.
- ◆ The team that wins the championship game will be awarded a trophy immediately following the game.

## Seeding Details:

- ◆ Six points will be awarded for each game won.
- ◆ Three points will be awarded for each game tied.
- ◆ One point for a shutout
- ◆ One point for each goal scored up to three per game
- ◆ Tie breakers for schools with the same amount of points will be based on 1) head to head 2) goals allowed 3) goals scored 4) Penalty Kicks
